#### **ADOPT-A-HIGHWAY**

The Lake Acres Adopt-A-Highway team will swing into action on **Sunday, 9 November at** 1:00 PM, assuming the weather cooperates. It's a Redskins bye week, so that excuse won't fly. Our community maintains the two-mile section of Gordon Road (Rt. 627) between the Ni River Bridge and Goshen Baptist Church. All residents are invited to participate. The more, the merrier! This is a great way to meet friends and neighbors and the more help we can generate, the faster the work goes. Normally, a crew of eight can clean the roadway in about two hours. No special skills are needed, just a willingness to work and a pair of sturdy gloves. Bags and road vests will be provided.

# Covenants

Have you read your covenants or deeds of dedication lately? There are very few restrictions, but there are some that are in place and should be respected. One of the things our covenants really focus on is the presence of "junk cars" in the neighborhood. If

you have a vehicle of any sort that is not properly licensed and registered, it should not be visible in you driveway, or on the street. You are responsible for seeing to it that the unlicensed, unregistered vehicle is out of sight. If you have one of these problems lying around, now might be a good time to call one of the charitable foundations that will remove the vehicle at no charge and provide you with a potentially valuable tax break! Our covenants also state that "A recreational vehicle may be kept on the property to the rear of the front line of the dwelling constructed thereon. Also, "owners of lots in said subdivision, whether said lots be built on or not, shall keep their lots free of junk cars, weeds, undergrowth, garbage, trash and unsightly debris and litter. Finally, "no commercial vehicles, trucks or equipment shall be parked on any lot except for a light pickup or panel delivery truck which may be parked to the rear of the front line of the dwelling constructed thereon."

Also, renters are required to abide by the covenants; if you are a landlord it is your responsibility to see that your tenants area aware of their community responsibility.

#### **BE A GOOD NEIGHBOR**

Residents are reminded that the properties around the pond (not on the reservoir) are private. Unless you have permission from the landowner, you do not have access to the pond for fishing or recreation purposes. Many of the Pond People are glad to extend access rights if you ask, but we would remind you that just because you've fished in the pond for years, you shouldn't assume that it is open for access to all.

Also, there have been numerous reports of afterhours use of the Pavilion area, access by nonresidents, improper and/or illegal campfires, and destruction of some of the picnic tables. Members are reminded that the common area is for use by Lake Acres residents <u>ONLY</u>! Guests must be accompanied by a resident, and we would encourage adult supervision for family outings in the area.
