Covenant Updates

The Board of Directors was informed that several members of the HOA desire to update the Restrictive Covenants to allow the keeping of chickens. In order to update the Restrictive Covenants a majority vote (51%) by the members of the HOA who are in good standing must be reached. The deadline to vote was set for March 1 and the results of the votes cast are as follows:

In favor: 65Opposed: 19Abstain: 46

A majority was achieved and the HOA will modify the Restrictive Covenants to allow the keeping of chickens. The Board of Directors are now working on the details and the process that is required to update the Restrictive Covenants.
